



HAUGHLEY PARK BARN NO CORKAGE & DRINKS POLICY



We have an obligation as a licenced venue to act in the interest of sensible consumption of alcohol. Our day-time drinks policy allows you to provide a good quantity of well-chosen drinks with no additional corkage charge, making it easier to budget and suit your personal requirements. We do not allow excessive supply or too many choices as we find that this leads to headaches, both before and after the day! **Please note that your no-corkage supply must be served by serving staff**, and if these are not supplied by your caterer, staff will need to be hired in separately to cover the drinks reception and wedding breakfast.

BEFORE THE CEREMONY	We have a strict no alcohol policy before the ceremony, in line with recommendation from the registrars. Refreshments are not usually provided for guests at this point.	We supply water. If you decide to serve soft drinks or tea/coffee , you must organise this with your caterer.
AFTER THE CEREMONY	A couple of alcoholic drinks and a soft option or two at this point is usually plenty to cover all tastes and keeping things simple gives a smart appearance to the provision, as well as making the buying a lot easier for you!	Classic drinks such as Pimms or a sparkling wine are the most crowd-pleasing. Bottled beers are also very popular, often provided in 'ice baths'.
WEDDING BREAKFAST	As a formal meal, we would assume the customary service of wine with the wedding breakfast, along with water and a drink for toasts . If there are children present, make sure that there is a soft-drink option. Alcoholic wedding favours can NOT exceed 50ml per adult and must be agreed with the bar supplier – Fizz Bar Events – in advance.	You can supply red, white and rose wines for each table. Beer can be served by your caterer on request, but in glasses rather than bottles. Champagne or prosecco will be perfect for toasts - one glass per adult is plenty!
END OF SERVICE		
The No-Corkage supply finishes at the end of the wedding breakfast, and does not include any drinks for your evening guests. Following clearance of the main course, no more fresh bottles may be placed on the tables. However, any part-bottles may be left on the table for top up purposes. Serving staff will remove all bottles after dessert is served and return them to the storeroom. Leftovers from your supply will then be locked away for collection next day.		

YOUR OPTIONS

YES	Pimm's, Prosecco, Champagne, Bottled Beers, Mulled Wine, Red Wine, White Wine, Rose Wine, Juices, Cordials/Squash, Soft Drinks
NO!	Whisky, Vodka, Gin, Rum, Spirits over 20%ABV, Home brewed beer, Kegs/Casks of Beer
ASK	Bottled Ciders, Home-made liquors, Dessert Wines, Spirits under 20%ABV, Digestifs
